Aarvi Encon Wins Work Orders of approx INR 10.47 Crores annually from Bharat Oman Refineries Ltd (BORL) for a period of 5 years. Total contract value will be more than 50 Cr in 5 years.

Aarvi Encon wins the following work orders from Bharat Oman Refineries Ltd. The said work orders considered material in the opinion of the authorized key managerial personnel for determining the materiality of an event or disclosures as per the SEBI (Listing Obligation and Disclosure Requirements) Regulation, 2015.

The Company has received a contract of Rs. 10,47,60,000/- (Rupees Ten Crores Forty Seven Lakhs Sixty Thousand only) annually for providing Management, Operations and Maintenance (O&M) Services for Bina Dispatch Terminal (BDT) of BORL, Bina, District Sagar, Madhya Pradesh, India. The contract is for a period of 5 years (60 Months) and the Company will commence the work w.e.f February 01, 2021. The aforesaid contract price has been fixed for the first year (12 months) and thereafter the contract prices from 2nd year onwards will be computed based on CPI and/or WPI Indices as per tender conditions. Total work order value will be more than 50 Cr in 5 years.

Bharat Oman Refineries Limited (BORL) was incorporated in 1994 as a Public Limited Company with equal equity participation of Bharat Petroleum Corporation Limited (“BPCL”, a Government of India Undertaking) and OQ (formerly OOC). Presently, BPCL is holding 63.4% and OQ is holding 36.6% equity in the Company. The company has become subsidiary of BPCL effective from 1st April, 2020. The Government of Madhya Pradesh is also stakeholder in the Company.

With significant co-operation from the Government of Madhya Pradesh, BORL set up a six million tonnes per annum (6.0 MMTPA) grassroots petroleum refinery at Bina, M. P. in the serene surroundings of Bundelkhand. Dedicated to the nation in May 2011 by then Hon’ble Prime Minister of India, the refinery produced environmentally compliant fuels of BS-IV grade.
