Gist of Proceedings of the 34th Annual General Meeting (Fifth AGM Post - IPO of the Company) of Aarvi Encon Ltd.

1. Date, time and venue of the Meeting:

The 34th Annual General Meeting (Fifth AGM Post IPO of the Company) was held on Friday, July 29, 2022 via Video Conferencing (VC) or Other Audio Visual Means (OAVM).

The Meeting commenced at 11:00 A.M. and concluded at 11:28 A.M.

2. Proceedings in brief:

- Mr. Virendra D. Sanghavi, Managing Director of the Company, chaired the proceedings of the meeting. The requisite quorum being present, the chairman called the Meeting to order.
- 26 Members present in person to conduct the proceedings of this meeting.
- The Chairman apprised the members about the performance of the Company during the F.Y. 2021-22. The Chairman also informed that the facility for remote e-voting commenced at July 26, 2022 at 10.00 A.M. and ended on July 28, 2022 at 05.00 P.M. Further, the facility to vote on resolutions through electronic voting system at the AGM was made available to the members who participated in the AGM and had not cast their votes through remote e-voting. The AGM was in compliance with the Circulars issued by the Ministry of Corporate Affairs, Government of India and Securities and Exchange Board of India.
- On Invitation by the Chairman, some members raised queries on various matters, have asked the queries in the Meeting, which were duly addressed by the Mr. Jaydev Sanghavi, Executive Director & CFO to their satisfaction.
- The 34th AGM held through Video Conference Mode and Other Audio/Visual Means and the resolution mentioned in the notice convening this AGM have been put to vote through remote e-voting.

The following items of business were transacted at AGM:

Ordinary Business:

1. Adoption of:

- a) Audited Standalone Financial Statement of the Company for the Financial Year ended March 31, 2022 and the reports of the Board of Directors and Auditors thereon; and
- b) Audited Consolidated Financial Statement of the Company for the Financial Year ended March 31, 2022 and the report of Auditors thereon.

2. To declare dividend of Re. 1.5/- per equity share for the Financial Year ended March 31, 2022.
